Courts may be rented for 30, 60 or 90 minutes at a time. Rates are per court, per hour. Not a per person charge.

### GENERAL NOTES

- Lifetime Activities requires either a court monitor or an instructor to be present at any event rental for the duration of the event, billable to the event organizer. All event attendees must sign a waiver prior to or at the beginning of the event. If an event occupies multiple facility rental spaces simultaneously, please note that an additional monitor will be required.
- For events involving court rentals, please note that if attendance exceeds 20 people, additional facility rental space will be required.
- For events with 60+ attendees/spectators, additional requirements, charges or fees may apply depending on the size and scope of the event. Additional fees (i.e., Event Oversight/Administrative fee) will be assessed for medium-large event requiring special set-up, breakdown, staffing an/or other services.
- Rental rates include exclusive use of the given resource and reservation confirmation from 9 days to 1 year prior to the event.
- Tennis Court Rentals for more than 8 courts have limited availability and must be approved by SF Recreation and Parks Department (RPD)
- Full facility buyouts have limited availability and must be approved by RPD; pricing will be determined by the size/scope of the event.
- Exclusive use of the lounge, locker rooms, parking, alcohol license, road closure, park access, etc., must be approved by RPD. Additional fees may apply.
- Use of the kitchenette is included at no additional charge with 1 or more facility resource rentals.
- Legacy programs such as high school league matches, SF Junior & Adult Opens will occur free of charge for associated schools and providers (i.e., TCSF, RPD).
- Legacy Events, such as the US Gay Open or GLTF Cal Cup, will receive the lowest tier court rental price, even if exceeding the use of 5 courts.

### INDIVIDUAL NOTES

- Individuals may request an advanced group reservation for tennis courts, recreation room, or outdoor garden for a specific event.
- Individuals may not reserve tennis courts to have a standing reservation for themselves, their team, their friends, or family members.

### NON-PROFIT NOTES

- Additional fees will be assessed for non-profit events involving ticket sales or other charges to attendees.
- Lifetime Activities will cohost monthly TCSF and quarterly TCAC meetings (in the GTC Rec room); therefore, no rental fees will be charged.

### FOR-PROFIT NOTES

- For-profit entity rentals will be available in limited supply
- For-profit entity rentals will only be approved provided they can be facilitated around legacy, non-profit, and community-based activities/events.
